**SELECTION ANNOUNCEMENT FOR SCHOOLS OF ENGINEERING PEER-TO-PEER
TUTORING ACTIVITIES - A.Y. 2023/2024 - I SEMESTER**

HAVING REGARD TO Art. 2 para. 4 of the Italian Prime Ministerial Decree of 9 April 2001;

HAVING REGARD TO Art. 11 of Italian Legislative Decree No 68/2012;

HAVING REGARD TO the resolution passed by the Academic Senate on 17/07/2023, which approved the outline of the Selection Announcement, including the possibility to update it in order to immediately apply the provisions set forth in the new 'University Regulation for the assignment of part-time collaborations to students' in the event of its entry into force prior to the issue of this Announcement;

HAVING REGARD TO the resolution passed by the Board of Governors on 25/07/2023, which approved the outline of the Selection Announcement, including the possibility to update it in order to immediately apply the provisions set forth in the new 'University Regulation for the assignment of part-time collaborations to students' in the event of its entry into force prior to the issue of this Announcement;

HAVING REGARD TO the entry into force, with Protocol No 0183948, of the new 'University Regulation for the assignment of part-time collaborations to students' on 31/07/2023;

HAVING APPLIED the necessary updates in the light of the new Regulation;

HAVING ACKNOWLEDGED the availability of funds from the Schools of Engineering,

HEREBY DECREES

ART. 1 PURPOSE

A selection competition reserved for students enrolled in a Laurea triennale (equivalent to Bachelor of Science) programme at the Schools of Engineering is announced for the definition of rankings of those eligible for peer-to-peer tutoring activities.

ART. 2 TYPES OF ACTIVITY

The student tutor will be responsible for:

- providing guidance to students on the practical organisation of their studies (study plans, teaching organisation, etc.) and the support facilities offered by Politecnico;
- being a point of reference for students on Laurea programmes with regard to any problems relating to the teaching or the way assessment tests are conducted;
- supporting students who find some difficulties and therefore need to fill limited basic gaps by providing help with clarifications and solving exercises (no explanation of programme content).

ART. 3 ADDRESSEES

Participation is open to all students who, for the 2023/2024 A.Y., are enrolled in School of Engineering Laurea triennale programmes and have obtained, as of 10 August, at least 50 ECTS with a weighted average of marks ≥ 25 (according to the ECTS obtained).

ART. 4 SUBMISSION DEADLINES

The application for participation must be submitted via the appropriate **function available from Online Services** (section 'Richieste di ammissione' > 'Ammissione a procedure di selezione')

from 28 August and no later than 12:00 (Italian time) on 20 September 2023

ART. 5 RANKINGS

The rankings, distinguished by School and Campus, will be defined by assigning a score following the formula:

**WEIGHT AVERAGE OF MARKS x REGISTERED ECTS (as of 10
August 2023)**

The ECTS relate only to actual exams duly registered in the academic career by the announcement deadline (**20 September 2023**), ie excluding exams to be validated from a previous academic career, additional exams, traineeship-type exams and exams relating to the final exam (or similar).

In the event of an equal score, candidates in the most disadvantaged economic situation according to their ISEE (Equivalent Economic Situation Indicator) or ISEEU parificato (for those who have no income in Italy) certificate resulting from the student database on the deadline of the Selection Announcement will take precedence in the ranking; in the absence of such ISEE/ISEEU certificate, students will be assigned, for the sole purposes of this ranking, the highest ISEE/ISEEU economic value as indicated in Table 1 of the Regulations on student contributions.

In the event the scores are still equal the candidate who is younger in age will prevail.

Students can view their position on the provisional ranking list by accessing the '**Submission of application for 200 hours/tutoring collaboration**' service, available in the online services, from **25 September 2023**.

ART. 6 ASSIGNMENT OF TASKS

Tasks will be assigned following the order of each ranking list.

Students are automatically ranked in the list of the School/Campus to which they belong; however, they may specify an alternative Campus at which they wish to collaborate.

Collaborations which need to be carried out by students with special requirements (eg passing specific exams, language skills, etc.) in order to be really effective and helpful may be assigned by way of derogation from the ranking order.

In the event the tasks to be assigned in the relevant School/Campus are not assigned completely after reaching the bottom of the ranking list, students on the ranking lists of other Schools/Campuses running out of convocations may be called upon.

The rankings will be valid until the selection list for the following Schools of Engineering Peer-to-Peer Tutoring Announcement is published.

ART. 7 CONVOCATION

The convocation takes place by e-mail sent to the institutional mailbox, by telephone contact or by videocall.

Each student may only start his/her activity after the contract formalising the assignment has been signed and registered.

The student may renounce an assignment, while keeping his/her position on the ranking list, only once; a second renouncement results in disqualification from the ranking list.

ART. 8 COLLABORATION MODALITIES AND DURATION

Each collaboration may not exceed 200 hours per calendar year. Similarly, in the case of multiple collaborations, the student's total commitment may not exceed 200 hours per calendar year.

On the basis of specific needs, collaborative assignments may be activated for a lower number of hours

Politecnico di Milano only provides accident insurance cover.

Collaborations must be carried out within the spaces used by the University for its activities. They may also take place in external locations, provided they are authorised in advance for carrying out the activities and under the direct coordination of internal staff. They can also take place in 'remote' mode.

The two modes ('face-to-face' and 'remote') may also alternate, based on specific needs and requirements.

Service performance modalities and period are established by the Head of the School or by any contact person he/she may have indicated, who is also responsible for informing the Diritto allo Studio service of any negative assessment of the activity carried out by each student.

The above activities do not in any way constitute an employment relationship nor do they entail the integration of students into the work organisation of the

University's administrative and teaching services or give rise to any assessment in the context of public competitions.

In the case the collaboration is not in line with the required quality, the contract will be terminated in accordance with the relevant clause therein.

Assigned students may terminate their collaboration by giving at least 5 working days' notice to the Head of the School or his/her contact person.

In the above cases, remuneration will be proportional to the hours worked. Students who interrupt their collaboration for any reason will not be entitled to apply for further assignments to complete the 200 hours.

The student lapses from the ranking list in the following cases:

- a) withdrawing from studies or transfer to another university;
- b) obtaining a degree;
- c) disciplinary measures beyond a warning.

ART. 9 EXCLUSION

The university Administration may, at any time, exclude a student from the activity in cases where he/she is not in good standing with regard to enrolment in the study programme or in cases of non-compliance with the duties arising from the collaboration relationship in question. If the collaboration is interrupted before its completion, the university Administration may activate new collaborations for the remaining hours, using the relevant ranking list.

ART. 10 REMUNERATION

The hourly remuneration for cooperation is set at €14.00.

The remuneration received is compatible with receiving the 'Borsa per il Diritto allo Studio Universitario'.

Politecnico di Milano only provides accident insurance cover.

For each collaboration, the remuneration is paid in the form of a lump sum by the University Administration upon a certificate issued by the person entrusted with the supervision of the activity.
