In 1987 the territorial diffusion process of the University began, the Politecnico Network, which led to the opening of the regional campuses of Como (1987, active until 2018) and Lecco (1989) and of the regional facilities in Cremona (1991), in Mantova (1994) and in Piacenza (1997), with the aim of establishing a more direct relationship with the students and interacting with the community's local businesses.

In the Bovisa area of Milan, where various disused warehouses and old gas tanks were found, starting in 1989 a university campus emerged with the new Schools of Civil Architecture, Design, and Industrial Engineering and some of the most advanced and innovative laboratories in Europe: the Wind Tunnel, for the development of research in the field of fluid dynamics, the Transportation Security Laboratory, where spectacular crash tests are performed, in addition to the Design Laboratories.

In 2021, the new Architecture campus designed by Renzo Piano in the area of via Bonardi was inaugurated in Milan Leonardo, which has led to an increase in open and study spaces available to students and an improvement in the environmental quality through the creation of extensive green spaces.

English OFA and OFA Test are assigned to students who enroll in a Laurea (equivalent to three-year Bachelor of Science) if any weakness is found in his/her basic education. The student is required to recover these weaknesses (through the fulfilment of OFA) during the academic year and according to the methods described in the following pages.

Students enrolled in English-language degree courses in Civil Engineering (international track), and Architectural Design (international track) must meet the English OFA additional educational obligations by submitting one of the certifications shown in the table on the students' page for the English-language Laurea Triennale (equivalent to Bachelor of Science) programmes to the Registrar's Office.

The TENG English section of the TOL, for students of the English-language degree course in Civil Engineering, and the ARCHED test, for students of the English-language degree course in Architectural Design, is insufficient to certify the required level of knowledge.

Attention: the assignment of OFA implies restrictions in the compilation of the Study Plan. These restrictions remain active until the student recovers the OFA. If the OFA are fulfilled after the deadline provided for submitting the Study Plan, the student can still submit one with limitations.

POK (Polimi Open Knowledge), launched in June 2014 by the Politecnico di Milano, is the first Italian university MOOCs (Massive Online Open Courses) platform offering free online courses open to everybody.

The main goal of the portal is to support students, not only from the Politecnico di Milano, in their university and professional careers: from high school to university, from bachelor to master degree, from university to the workplace. There are also many other courses for teachers, researchers, professionals and citizens.

All you need to do to log in is to have your own account. It is possible to create a Polimi account - a recommended choice because it is the only way to obtain certificates of participation in completed courses - or a POK account. Once you have logged in to the platform, you can enrol in the courses autonomously and take advantage of all the materials, videos, activities and self-assessment tests.

At the end of the course, if a minimum score is met, a certificate of attendance will be issued (not tied to university credits or to the Politecnico entrance test).

Internship is a training experience at the workplace that allows you to:

- put into practice the know-how acquired at theoretical level during the Programme of Studies
- orient yourself towards an informed future professional choice

You can undertake an internship in Italy or abroad, at companies, at professional studios, at foreign universities or at public and private research institutes.

Before embarking on this experience, it is necessary for the host institution to ask the Politecnico di Milano to issue two documents required by law (Traineeship Agreement and Training Project).

The internship/traineeship may be:

- curricular and compulsory: that is, provided for in the Study Plans and linked to the acquisition of university credits (CFU/ECTS)
- curricular but optional: that is, undertaken as a student, but no university credits are acquired and for a maximum duration of 12 months to be concluded in any case prior to the thesis discussion
- extra-curricular: that is, undertaken as a new graduate not enrolled in another university programme; maximum duration is of 6 months
