HAVING REGARD TO Italian Presidential Decree No 445 of 28.12.2000;

**HAVING REGARD TO** Articles 2 and 12 of Italian Prime Ministerial Decree of 9 April 2001, 'Equal treatment in the right to higher education';

**HAVING REGARD TO** the Regulation for Administration, Finance and Accounting, issued by Rectoral Decree No 828 Ref. No 7766 of 14/03/2014 and in particular Articles 75 and 79;

**HAVING REGARD TO** letter ref.no.175279/2023 of 24/07/2023 in which Dr Elisabeth Rizzotti, sole director of *newcleo* Srl expressed her willingness to donate to Politecnico di Milano a total of  $\notin$  40,000 for two scholarships for students in their 3rd year of degree programmes at Politecnico di Milano who will continue their studies in the Laurea Magistrale programme (equivalent to Master of Science) in Nuclear Engineering at Politecnico di Milano;

**HAVING REGARD TO** Managerial Decree No. 8886/2023 Ref. No. 176997/ 2023 of 25/07/2023, with which the donation offered by *new*cleo was accepted;

#### HEREBY DECREES

The issuing of the call for applications for **2** "*newcleo*" scholarships for the academic year 2024-2025.

# Art. 1 Introduction

*newcleo* is a private company launched in 2021 to be an innovator in the field of nuclear energy, generating safe, clean, cheap and abundant energy. The company aims to design, build, and operate Small Modular Lead-cooled Fast Reactors to effectively address the three challenges that have occupied the nuclear industry to date: waste, safety and costs.



*new*cleo is also preparing for significant investments in MOX fuel production, extracting the full energy content of the extracted nuclear material.

In its first two years of existence, *new*cleo has been able to rely on more than 430 employees in Italy, France and the UK, several crucial acquisitions and partnerships, €400 million of investments and a capital increase up to €1 billion.

A fundamental and integral part of *newc*leo's mission is to support and promote the European nuclear industry, including through the development of the necessary skills, mainly by supporting the academic career of young students. Recognising the importance of the excellent academic education offered by Politecnico di Milano, *newc*leo maks available 2 scholarships for students to complete the Laurea Magistrale programme (equivalent to Master of Science) in Nuclear Engineering at Politecnico di Milano. Offering students this financial aid, the company aims to support scholarhip applicants on the basis of both their financial situation and academic achievements, to facilitate access to excellent education for deserving applicants.

### Art. 2

# **Scholarship Recipients and Characteristics**

Two (2) scholarships, each of € 10,000.00 gross per year for two years, inclusive of the fees to be borne by Politecnico di Milano, for students on 2023-2024 a.y. Laurea programmes (1 level programmes, equivalent to Bachelor of Science) at Politecnico di Milano who:

- 1. obtain their degree by the **September 2024** session;
- 2. continue their studies in the **2024-2025** academic year in the Laurea Magistrale programme (equivalent to Master of Science) in **Nuclear Engineering - Ingegneria Nucleare** at Politecnico di Milano.

The scholarships will be provided for two academic years for a total value of  $\bigcirc 20,000$  each.

The scholarships will be confirmed and the amount allocated in the 2024-2025 academic year will be disbursed for the following academic year provided that the requirements set out in Art. 6 of this call are met.



# Art. 3 Participation requirements

The call is open to students who meet the following requirements by the deadline of the call for applications:

- 1. **enrolment** in a Laurea programme (first level) at Politecnico di Milano in the**academic year 2021-2022**
- 2. **registration** in a Laurea programme (first level) at Politecnico di Milano for the**academic year 2023-2024**
- 3. **at least 140 ECTS** which have been correctly registered on the student's record and are eligible for the purposes of graduation (including validations)
- 4. weighted average **not less than 27/30** of examinations which have been correctly registered on the student's record and are eligible for the purposes of graduation

The Fundraising and Alumni Unit will verify whether the requirements have been met, using Politecnico di Milano's digital archive.

It is the applicant's responsibility to ensure that the data present in Politecnico di Milano's digital archive are correct and current by the deadline of this call for applications.

# Art. 4 Application procedure

Applicants must submit an application using the relevant function available within Online Services <u>http://www.polimi.it/servizionline</u> (Agevolazioni e Convenzioni > Borse di studio, premi di laurea, esoneri, bandi generici) **by 12:00 noon (Italian time)** on **29 March 2024**.

Upon completion of the online application process (status:closed), the application to this call shall be deemed to have been submitted and the applicant shall be understood to have agreed to the contents of the call itself.

It is the applicant's responsibility to check that the process has been completed correctly.

After having completed and submitted the application, the applicant may print a receipt and the application may no longer be altered. The applicant may delete the application and submit a new one at any time before the deadline set out in this call.

Failure to complete and submit the application, submitting an incomplete application or submitting inadequate documents shall result in the applicant being excluded from the assessment procedure.



# Art. 5 Awarding of the scholarship

The scholarship will be awarded according to a ranking list compiled by the office of the Fundraising and Alumni Unit based on the information available in Politecnico di Milano's digital archive.

The ranking list will be compiled according to the scores calculated by the formula:

# WEIGHTED AVERAGE OF MARKS x REGISTERED ECTS)+ FINANCIAL SITUATION SCORE (as of the call deadline)

The financial situation score shall be determined as follows:

2024 ISEE/ISEEU (Equivalent Economic Situation Indicator/ ISEE for University Use) VALUE	SCORE
from €0 to €23,120	120
from €23,121 to €27,000	120
from €27,001 to €31,000	80
from €31,001 to €40,000	70

from €63,001 to €75,000	10

€95,001 and above	0

To that end, the **valid and compliant 2024 ISEE** - Equivalent Economic Situation Indicator (or equivalent **ISEEU** - Equivalent Economic Situation Indicator for University Use for those with no Italian income) found in the University's **database** as of the **call deadline** will be considered.

In the event the scores are still equal, the candidate who is younger in age will prevail.

The final awarding of the scholarship will take place following verification of the following:

1. graduation by the September 2024 session



2. **enrolment** in the first semester **of the 2024-2025** a.y. of the Laurea Magistrale programme (equivalent to Master of Science) in **Nuclear Engineering - Ingegneria Nucleare** at Politecnico di Milano, within the deadlines set out in the academic calendar.

Some of the four scholarships may not be awarded in the event that applicants prove not to be suitable.

The winner may be invited to meet with the donor.

# Art. 6 Renewal of the scholarship

Recipient of the '*Newcleo*' scholarship for the **2024-2025 a.y.** may have their scholarship renewed for the following academic year provided that the following requirements are met:

- Registration for the 2025-2026 a.y. in the Laurea Magistrale programme (equivalent to Master of Science) in Nuclear Engineering -Ingegneria Nucleare at Politecnico di Milano, within the deadlines set out in the academic calendar.
- 2. obtainment of at least 50 ECTS which are eligible for the purposes of graduation by 30 September 2025.

The above requirements will be verified by Fundraising and Alumni Unit, enabling the automatic renewal of the scholarship.

In the event of a failure to renew, the scholarship-holder will automatically lose the right to any subsequent renewals.

# Art. 7

# **General rules**

**Cumulation** - the scholarship and any renewals cannot be combined with other scholarships or **other forms of financial aid provided by Politecnico**, **in particular with Diritto allo Studio Universitario (DSU) financial aid for the academic year in question.** The scholarship and its renewal may be combined with international mobility benefits provided by Politecnico or other public or private entities. The scholarship and its renewal may also be combined with exemptions from tuition fees and contributions.

The scholarship cannot be combined with the 'Marie Sklodowska-Curie (MSCFP)' scholarship.



**Revocation**: the scholarship may be revoked if disciplinary sanctions are brought against the recipient. In any case, the scholarship will be revoked if the recipient withdraws from his/her studies or transfers to another University during the year.

**Withdrawal:** in the event that the winner withdraws and/or fails to return the required forms by the relevant deadline, the scholarship will be awarded to the next eligible applicant in the ranking.

**Payment:** the winner of the scholarship will be notified about the award and any renewals through his/her university e-mail address. Within 10 days of receiving said notification, the winner must sign and return the corresponding forms attached to the award and renewal notifications.

The scholarship will be disbursed by Politecnico di Milano in a single payment.

In the event that the scholarship is not awarded and/or the holder fails to renew the scholarship, the remaining funds will be used to establish a new call for applications.

**Self-certification**: Politecnico di Milano will verify the recipient's declarations and any false declarations will result in the forfeiture of any benefits awarded.

**Taxation:** the scholarship will be subject to taxation, in accordance with current legislation relating to scholarships. The amount paid by way of scholarship shall be treated as employment income for tax purposes and shall therefore be subject to the same tax arrangements. The costs to be borne by Politecnico di Milano are the IRAP regional tax on production activities, amounting to 8.5% of the scholarship amount.

#### PRIVACY POLICY PURSUANT TO ARTICLE 13 OF THE EUROPEAN GENERAL DATA PROTECTION REGULATION (GDPR)

Politecnico di Milano (hereafter also *Politecnico*), in the role of Data Controller, with registered address in Piazza Leonardo da Vinci 32, 20133 Milan - General Management -, hereby informs you of the methods for processing your personal data, in compliance with Regulation (EU) 2016/679 of 27 April 2016 on the protection of personal data and respective implementing regulations (hereafter the *Regulation*).

The Data Processor of the data you have provided is the Head of the Research, Innovation and Corporate Relations Division.

# A. PERSONAL DATA COLLECTED

The personal data concerning you collected and processed by Politecnico are **(a)** the data provided by you at the time of registration or enrolment, including your name, surname, date and place of birth, gender, tax code, nationality, home address, telephone and email contact details, academic qualifications; **(b)** the data collected when you submitted your application, in particular those relating to your academic career and academic qualifications achieved.

# **B. PROCESSING PURPOSES AND METHODS**

Your personal data may be processed for the following purposes:

1. for the public interest of verifying the requirements for participation in the competition according to the criteria stated in this call for applications and all purposes provided for by law, including for statistical purposes.

In relation to the aforementioned purposes, the data processing shall be carried out by Politecnico di Milano using manual, computerised and electronic tools, in a manner that is relevant and limited to what is necessary with regard to the purposes for which they are processed and, in any case, in such a way as to guarantee the utmost security and confidentiality and always in full compliance with the legislation in force.

# C.MANDATORY OR VOLUNTARY NATURE OF DATA PROVISION

The provision of data for the purposes indicated in section B 1 is mandatory; any refusal to provide such data shall result in the inadmissibility of the application and immediate exclusion from the procedure. The provision of data for the purposes set out in paragraph B. point 2 is optional and any refusal to provide data will have no consequences.



# D. SCOPE OF COMMUNICATION AND CIRCULATION OF THE DATA

Your personal data shall be disclosed to Politecnico employees who are authorised to process such data, namely natural or legal persons who work with Politecnico for the purposes of implementing the procedures for the selection and awarding of the scholarship provided for by this call.

Your data will also be communicated to the AlumniPolimi Association for organising the award ceremony and other events related to the scholarship. In the event of any contact made by the AlumniPolimi Association, the Association shall be understood to be a distinct and autonomous data controller in its own right. As such, the Association shall provide you with the necessary privacy policy.

#### E. STORAGE AND POSSIBLE TRANSFER OF PERSONAL DATA

Your personal data will be stored at Politecnico di Milano and will not be transferred to a third country.

#### **F.DATA RETENTION PERIOD**

Your personal data shall be retained only for as long as strictly necessary in order to meet the requirements of this call for applications, unless it becomes necessary to retain and store the data for a longer period in the public interest. If the data are stored for longer periods, Politecnico shall ensure compliance with the principle of data minimisation pursuant to Art. 89, paragraph 1 of the Regulation.

## G. YOUR RIGHTS

We remind you that you have the right to: obtain information relating to the methods with which your data are processed and any other information stated in Art. 15 of the Regulation (*right of access*) rectify inaccurate personal data concerning you pursuant to Art. 16 of the Regulation (*right to rectification*) restrict the processing of your personal data pursuant to Art. 18 of the Regulation (*right to restriction of processing*); object to the processing of your personal data in the cases and by the methods set forth in Art. 21 of the Regulation (*right to object*)

By submitting an application, you declare that you have read and understood this privacy policy, as indicated in Art. 13 of the Regulation, and that you consent to the processing of your personal data.
