HAVING SEEN Presidential Decree 28 December 2000, no. 445;

HAVING REGARD to articles 2 and 12 of Prime Ministerial Decree of 9 April 2001, "Equal treatment in the right to university studies";

HAVING REGARD to article 75, paragraph 2 of the Regulation for Administration, Finance and Accounting of the Politecnico di Milano, issued with Rectoral Decree no. 828 prot. no. 7766 of 14/03/2014;

HAVING REGARD the letter ref. 116369/2023 dated 18/05/2023 with which the company Fabbrica Energie Rinnovabili Alternative S.r.l. expresses the intention to donate to Politecnico di Milano the sum of € 6,000 to promote study activity in the field of engineering through the provision of a degree award for graduates currently undertaking the Laurea Magistrale (equivalent to a Master of Science) in Energy Engineering;

HAVING REGARD to Managerial Decree no. 5808/2023 ref. no. 116922/2023 of 18/05/2023, which accepts the donation offered by Fabbrica Energie Rinnovabili Alternative S.r.l.;

DECREES

The issuance of the call for applications for the "Francesco Cesare Fera" degree award for 2023.

art. 1 Description of the degree award and recipients

The degree award will go to the applicant who has developed the best degree thesis from those dealing with topics related to: "Charging of electric and V2G cars and trucks".

The first person in the ranking will be awarded a prize of €4,000. The second and third persons a prize of €1,000 each.

The above amounts are gross and include costs to be paid by Politecnico di Milano.

Students who have obtained the following Laurea Magistrale (equivalent to Master of Science) from Politecnico di Milano are eligible to participate:

- in Energy Engineering
- in the period from January 2022 to May 2023



• with a graduation score of not less than 100/110

Fundraising and Alumni Unit shall check that applicants possess the necessary requirements.

art. 2 How to participate

Applicants must submit the application by way of the specific function available from the online Services http://www.polimi.it/servizionline (Agevolazioni e Convenzioni > Borse di studio, premi di laurea, esoneri, bandi generici [Subsidies and Conventions > Scholarships, degree prizes, exonerations, generic notices]) by 12pm (Italian time) on 30 June 2023.

Candidates **must attach**, by way of the relevant procedure:

-their degree dissertation in PDF format, with a maximum file size of 10MB

The file must be named with Surname-First Name-Document Type.pdf (for example, Rossi-Mario-Dissertation.pdf)

Completion of the online application is equivalent to submitting an application for participation in this call for applications, and implies acceptance of its contents. It is the applicant's responsibility to check that they have properly completed the procedure.

After having completed and submitted the application, the applicant may print a receipt and the application may no longer be edited. The applicant will, however, have the option of deleting the application and submitting a fresh application before the deadline set out in this call for applications.

Failure to complete and submit the application, submitting an incomplete application or submitting inadequate documents will result in the applicant being excluded from the assessment procedure.

By submitting an application, the winning applicant consents to their thesis or part thereof being published within the bounds of respect for copyright.



art. 3 Adjudicating Committee

The granting of the degree award is decided based on a ranking drawn up by a Selection Committee appointed by managerial decree following the deadline of the call for applications.

The Committee will decide the ranking based on the attached thesis.

It will be preferable to have developed contributions on wind energy as well as on the accumulation and distribution of electricity by motor propulsion.

Provided that the requirements set out in art. 1 of the call for applications are met, the Committee may share the award among several applicants if there is an ex-aequo.

The Adjudicating Committee may not award the prize if none of the applicants are deemed suitable.

The winner may be invited to a meet-and-greet with the donor.

art. 4 General rules

Cumulability: the degree award is not cumulable with other awards received for the same dissertation.

Withdrawal: in the event of the winner withdrawing or failing to return the necessary forms by the established deadline, the prize will be awarded to the next highest applicant in the ranking.

Payment: the awarding of the degree award will be communicated to the winner via their official university email address. Within 10 days of receipt of this communication, the winner must return the relevant forms attached to the award notification, signed for acceptance.

The prize will be paid in a single payment from the Politecnico di Milano.

Tax status: the payments awarded are subject to taxation, under the legislation in force regarding study awards. The amount paid as a degree award is income considered similar to income from employment, and as such is subject to the same taxation. The taxes paid by Politecnico di Milano correspond to the IRAP rate of 8.5% of the total degree award.

PRIVACY POLICY UNDER ARTICLE 13 OF THE EUROPEAN GENERAL DATA PROTECTION REGULATION (GDPR)

The Politecnico di Milano (henceforth also *Politecnico*), in the role of the Data Controller, with offices at Piazza Leonardo da Vinci 32, 20133 Milan – General Management -, hereby informs you about the methods for processing your personal data, in compliance with EU Regulation 2016/679 of 27 April 2016 relative to the protection of personal data and relative implementation regulations (henceforth the *Regulations*).

The Data Controller for the data you have provided is the Director of the Research, Innovation and Corporate Relations Division.

COLLECTED PERSONAL DATA

The personal data regarding you collected and processed by the Politecnico is (a) the data provided by you upon registration, such as name, surname, date and place of birth, sex, tax ID code, nationality, residential address, telephone and email contact details, educational qualifications; (b) the data collected upon submission of your candidature, in particular that related to your academic career, the degree programme you have completed, and the data contained in your dissertation.

A. OBJECTIVES AND METHODS OF THE PROCESSING

Your personal data may be processed for the following purposes:

1. for the public interest of verifying requirements for participation in the competition according to the criteria set forth in this call for applications and all other legal purposes, including statistical

In relation to the aforesaid purposes, processing of data by the Politecnico di Milano shall be carried out using manual, computerized and remote means, specifically limited to what is necessary in respect to the purposes for which the data are processed, and nevertheless guaranteeing maximum security and confidentiality and always in full compliance with current legislation.

B. MANDATORY OR OPTIONAL TRANSMISSION OF DATA

The transmission of data for the purposes set forth in section B point 1 is mandatory, and refusing transmission will result in inadmissibility of the student's candidature and immediate exclusion from the process.



C. SCOPE OF COMMUNICATION AND CIRCULATION OF THE DATA

Your personal data will be communicated to Politecnico employees who are authorised to process data. These are natural or legal persons who work for the Politecnico to implement the procedures for the selection and awarding of the benefit being competed for under this call for applications.

Your data will also be communicated to the company Fabbrica Energie Rinnovabili Alternative S.r.l. to inform it of the outcome of the call.

D. RETENTION AND POSSIBLE TRANSFER OF PERSONAL DATA

Your data will be stored at the Politecnico di Milano and will not be transferred to a third country.

E. PERIOD OF RETENTION OF THE DATA

Your personal data will be stored for the time strictly necessary to meet the requirements set forth by this call for applications, unless data storage becomes necessary for a longer period for public interest reasons. If the data is stored for longer periods, Politecnico guarantees compliance with the data minimisation principle under art. 89, point 1 of the Regulations.

F. YOUR RIGHTS

You have the right to:

obtain information on your data processing methods and any other information under art. 15 of the Regulations (so-called *right of access*)

to rectify any of your personal data that are erroneous pursuant to art. 16 of the Regulations (so-called *right to rectify*)

to limit the processing of your personal data pursuant to

art. 18 of the Regulations (so-called *right to limit processing*);

oppose your personal data processing in the cases and under the methods set forth in art. 21 of the Regulations (so-called *right to oppose*)
