

SPECIFIC REQUIREMENTS ACCORDING TO THE TYPE OF DIPLOMA

INTERNATIONAL BACCALAUREATE (IB)

All the students with an International Baccalaureate diploma (IB) must share their results through the <https://www.ibo.org/> website. In this case, is therefore not necessary to ask for CIMEA Statement of Verification. The students will be asked to upload their IB diploma, along with the grades of the last three years of school, with stamp and signature of the competent office.

EUROPEAN BACCALAUREATE (SCHOLA EUROPAEA), FOREIGN DIPLOMAS OBTAINED IN ITALY

Politecnico di Milano will contact the schools directly to verify the authenticity of such diplomas. Apart from the grades of the last three years of school, with stamp and signature of the competent office, the students will have to upload only the actual diploma.

BRITISH HIGH SCHOOL DIPLOMAS

The students who have obtained the 3 A levels required for the enrolment from the Cambridge Assessment International Education (CAIE) must share their results through the CAIE [website](#) and upload their General Certificate of Education, along with the grades of the last three years of school, with stamp and signature of the competent office.

All the other students will be asked to upload CIMEA Statement of Verification or the e-Apostille, unless an online verification tool is available, along with their General Certificate of Education and the grades of the last three years of school, with stamp and signature of the competent office.

CHINA HIGH SCHOOL DIPLOMAS

All the Chinese diplomas, as well as the GAO KAO exams, can be verified online through the CSSD (China Credentials Verification) website: <https://www.chsi.com.cn/en/>.

Apart from the declaration of value, or the CIMEA Statement of Comparability, students with a Chinese high school diploma must upload the "Verification Report of China Secondary Education Qualification Certificate" for both the diploma and GAO KAO certificate, and the grades of the last three years of school, with stamp and signature of the competent office.

TURKEY HIGH SCHOOL DIPLOMAS

All the Turkish high school diplomas can be verified online, as well as the YKS university entrance exam. It is therefore not necessary for the students to ask for CIMEA Statement of Verification.

Apart from the grades of the last three years of school, with stamp and signature of the competent office, the students will only have to upload their high school diploma and YKS certificate.

FRENCH SECONDARY SCHOOL DIPLOMAS

Students with a French secondary school diploma, apart from the grades of the last three years of school, with stamp and signature of the competent office, will have to upload one document between the Relevé des Notes du Baccalauréat and the Attestation de Réussite.

RUSSIAN FEDERATION SECONDARY SCHOOL DIPLOMAS

Unfortunately, the e-Apostille on Russian documents cannot be verified with the internet providers currently in use.

Therefore, unless a digital verification method is offered by the institution, apart from the declaration of value or the CIMEA Statement of Comparability, and the grades of the last three years of school, with stamp and signature of the competent office, students with a Russian secondary school diploma must upload their title accompanied by CIMEA Statement of Verification.

UNITED STATES OF AMERICA SECONDARY SCHOOL DIPLOMAS

Apart from the standard documents required, students holding a US high school diploma must share with Politecnico di Milano the results of the 3 Aps necessary for the enrolment from the [College Board](#) website.

IRANIAN SECONDARY SCHOOL DIPLOMAS

Students with an Iranian secondary school diploma, must apply for the verification of its authenticity at the Uni-Italia Center in Iran. The office can be reached at the following e-mail address: iran@uni-italia.it.
