CONSIDERING that Politecnico di Milano is a member of the European Universities Alliance ENHANCE;

CONSIDERING that Warsaw University of Technology (WUT), is organizing a Summer School in the period 04-14 July 2023;

GIVEN the availability of economic funds;

HEREBY DECREES

the publication of this call for the selection of students who will participate in the "Enhance students against climate change" Summer School organized by Warsaw University of Technology (WUT) - Warsaw.

The summer school will be held between 04-14 July 2023 and will take place in a blended modality:

• July, 4th and 5th: online

• July 10-14: in person

Art. 1 - Target audience

This call for applicants is intended for students, from all the Schools of Politecnico di Milano, who, at the closure of the call are enrolled for the a.y. 2022/23 in:

- in the 2nd or 3rd year of a Bachelor's Degree course;
- -in the 1st year of a Master's Degree course (enrollment in the 1st semester a.y 2022/2023);
- in the 2nd year of a Master's Degree course;
- in the 2nd, 3rd, 4th or 5th year of the 5-year single cycle programme (laurea magistrale a ciclo unico)



Art. 2 – Description of the project

Please note that knowledge of English is mandatory at B2 level.

There are no tuition costs.

A gross amount of € 756,00 will be provided to partially cover the costs of travel, accommodation and meals, net of the fees to be paid by Politecnico.

The activities carried out may count towards the student's academic career based on the rules set by each School.

Art. 3 - Applications

In order to take part in the selection, it is necessary to submit the application form through the **dedicated function available from the On-line services** (section Admission Inquiries> Admission and selection procedure) **within 12.00 (Twelve - Italian time) of 26**st May 2023.

The closure of the on-line application is equivalent to submitting the application.

Failure to close or complete the application results in the exclusion from the selection procedure.

Art. 4 – Participation requirements and selection process

Students who, at the closing date of the call for applications, have obtained a weighted average of at least **27/30**, may participate in the selection, provided they have also achieved:

- at least **80 ECTS** if enrolled in the 2nd year of a Bachelor's Degree (Laurea Triennale) or in the 2nd year of the 5-year single cycle programme (Laurea Magistrale a ciclo unico)
- at least **120 ECTS** if enrolled in the 3rd year of a Bachelor's Degree (Laurea Triennale) or in the 3rd year of the 5-year single cycle programme (Laurea Magistrale a ciclo unico)
- at least **20 ECTS** if enrolled in the 1st year of a Laurea Magistrale programme (with registration in the first semester of the academic year 2022/23);
- at least **50 ECTS** if enrolled in the 2nd year of a Laurea Magistrale programme (with registration in the second semester of the academic year 2021/22);
- at least **80 ECTS** if enrolled in the 2nd year of a Laurea Magistrale programme (with registration in the first semester of the academic year 2021/22);
- at least **204 ECTS** if enrolled in the 4th year of the 5-year single cycle programme or **260 ECTS** if enrolled in the 5th year of the 5-year single cycle programme.

The rankings will be defined on the basis of the weighted average, calculated on credits useful for the achievement of the degree, already achieved and regularly registered in the student's career at the aforementioned date, as well as on the basis of the credits



achieved in respect to the minimum number of credits foreseen for each semester (30 ECTS).

A number of **5 students** will be nominated for the participation in the Summer School:

- 2 students among Bachelor's Degree students;
- 2 students among Master's Degree students;
- 1 student among students enrolled in the 5-year single cycle programme (laurea magistrale a ciclo unico)

In case the number of eligible applications should not cover all slots, the attribution of places between the different categories of students may vary.

Selected students will receive a specific communication to the institutional email address by **30th May 2023** and they must fill in an online application within June, 2nd.
