Industrial Property Course – Patents 2021 edition

April 2021 – July 2021

COURSE DESCRIPTION

The Industrial Property Course – Patents, organized by Politecnico di Milano, is aimed at providing a professional training in the IP field, with a specific focus on the Unitary Patent and the Unified Patent Court.

The course will be held online. It will end with three days of practical exercises, comprising case studies, a mock negotiation and a mock litigation. These last three days of lectures will be held in presence.

The final exam will be organized immediately after the exercises and it will comprise a first part with multiple choice questions and a second part with an open question.

COURSE PARTICIPANTS

The Industrial Property Course - Patents is aimed at the attainment of the Patent Litigator qualification according to R. 12 of the Draft rules on the European patent litigation certificate and other appropriate qualifications pursuant to article 48(2) of the agreement on a Unified Patent Court.

TRAINING FORMAT AND DISTANCE LEARNING

Lectures will be held in English and the course will comprise a total of 120 hours from April to July 2021.

At the end of the course there will be three days of exercises, with mock litigations and mock negotiations.

Due to the present pandemic emergency the lectures will be held online through the Microsoft Teams platform.

All the participants will have access to video-recordings of the lectures, the presentations and the material of the course, which will be downloadable from the website with a personal password.

Since, according to the Rule 5(2) of the Draft EPLC rules, practical training always requires personal participation, the three days of exercises at the end of the course will be organized when the pandemic situation will be cleared and travelling will not represent a risk.

QUALIFICATION CERTIFICATE AND CREDITS

The Industrial Property Course – Patents is in the list of R. 12(a) (Other qualifications during the transitional period) of the Draft Decision of the Administrative Committee on rules on the European patent litigation certificate and other appropriate qualifications pursuant to article 48(2) of the agreement on a Unified Patent Court (Draft EPLC rules), and, for a period of one year from the entry into force of the Agreement on the UPC, the certificate issued after passing the final exam will be recognized as an appropriate qualification for European Patent Attorneys to be registered on the list of entitled representatives under Article 48(2) of the Agreement on a Unified Patent Court.

The course is accredited to the Ordine dei Consulenti in Proprietà Industriale.
