HAVING ACQUIRED the favourable opinion expressed by the Academic Senate in its meeting of 19 November 2018, regarding the new establishment and composition of the Ethical Committee and the reconfirmation of Prof. Carlo Ghezzi as President of the aforementioned Body, for the three-year period 2019/2021;

HAVING THUS RECOGNISED the need to take action;

HEREBY DECREES
